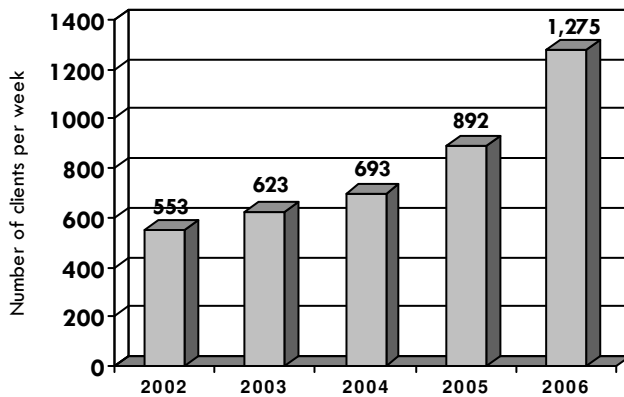

A year in review

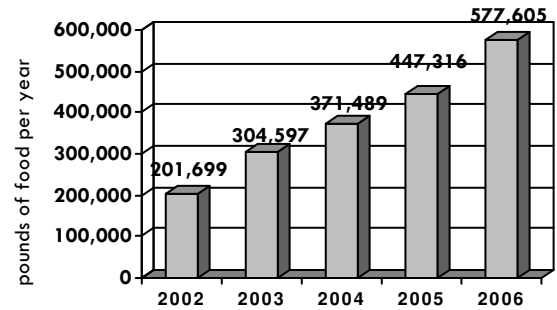
Highlights from the year 2006 include:

- We served an average of 1,275 patrons per week at our food pantry, or 59,759 total.
- We saw and met a 43% increase in demand for services.
- We distributed 577,605 pounds of rescued food, a retail value of over \$1.2 million.
- Our pantry was staffed by a crew of volunteers who collectively contributed over 60 hours each week, or more than 3,000 hours per year. 80% of our volunteers are also patrons.
- We raised over 1,200 pounds of organic produce at 3 community garden sites.
- We were the largest food distributor of the Hoosier Hills Food Bank, distributing 31% of HHFB's rescued food product in 2006.
- We completed a facility renovation and expansion which doubled the square footage of our pantry and added a private office and shared conference room.
